Executive Board Update	 The Executive Board met virtually back in April and this week on Monday, May 12, 2025. The Consortium Event Planning Taskforce has begun to convene and met on Friday, April 4, 2025, and Thursday, April 17, 2025. The Taskforce discussed the purpose of the event, tentative date/time, theme (Miami Vice), venue locations (Miami Vineyard, Milander, UM Alumni Center, and FIU), reviewed past promotional materials, and sponsorship packages. The Taskforce has also started to review draft materials for this year's event. This week on May 15th, the members will go to a site visit to Miami Vineyard to tour the venue. Please contact your committee liaison if interested in signing up to be a part of the Taskforce. The Board has approved the digital brochure. The brochure was now sent to DOH Communications. Once approved by Communications, we will begin to disseminate in English. There were also discussions once approved, to translate in Spanish and Creole. Presentation	The committee had a presentation presented by Sarah Suarez, PhD, MPH, of Miami-Dade County Office of Neighborhood Safety. The presentation was titled Office of Neighborhood Safety: Firearm Violence and the Built Environment. This initiative was launched under Mayor Daniela Levine Cava and it was started because of a mass shooting in Hialeah. Please see below main topics shared with a high-level recap.	
	Non-fatal violence is increasing:	
	About 2,000 victims that experienced a non-fatal assault.	
	We see higher rate of young males (up to 25) is the highest violence risk.	
	Strategic Goals: Built Environment is a pillar to focus on that can help strengthen informal social controls that deter violence.	
	 Proven to work by a program in Philadelphia that showed decrease gun violence by 39% over one year. 	
	 Creating wall murals and attention to communities helps reduce violence. Grouped zip codes in Miami from 2020-2024. The zip codes were separated into 4 groups. The social and economic factors are based on Employment rate, bachelor's degree or Higher, and Poverty Level. 	
	Violence in neighborhoods is concentrated and cyclical.	
	 Used the Tree Canopy for Miami-Dade County to see the zip codes and the homicide rates. Another program used for reference was Owned Vacant lots grouped in zip codes to analyze the built environment and compare homicide rates. This can be a point to help communities. Took 311 Calls in 2023.
