<p>Complete Streets Guidelines</p>	<p>RN -The FDOH signed an amendment with Miami Dade County to develop the complete streets guidelines. Miami-Dade County will work with at least three municipalities during the grant year to incorporate the guidelines into their transportation projects.</p> <p>CJ mentioned that she would connect with Patrice Gillespie to identify opportunities to link Active Design with the Complete streets initiative. The ADM team is currently working with the City of Miami on a bike parking ordinance to increase bike parking spaces.</p>

The inaugural Miami Park(ing) Day will be held on September 16. Incentives will be given out to the winners.</p> <p>Parklets are an inexpensive infrastructure innovation that can change the look and feel of a street and boost economic activity. They involve converting one to three on-street parking spaces into an attractive public gathering spot. Urban Impact Lab is working with the City of Miami on pilot parklet ordinance.</p> <p>The Public Transit Day is on December 9<sup>th</sup>, the goal is to encourage the use public transportation.</p> <p><u>Miami Dade Parks, Recreation and Open Spaces</u></p> <p>SB and KB is providing technical assistance to the Park 305 initiative. Dr. Brown and Joanna Lombard are in the process of developing the health messaging content. The beta version of the app will be tested in November. The formal launch of the app is scheduled for February.</p> <p><u>The Health Foundation of South Florida</u></p> <p>The Health Foundation of South Florida commissioned a report on Policy Opportunities to Support Healthy Food Systems &amp; Active Living for the City of Miami and Miami Gardens. The report includes findings from a review and an analysis of cities' comprehensive plan policies and zoning codes.
