Welcome and Introductions	The November 2025 monthly merged meeting of the Children Issues Oral Health Committee and Healthy Baby Taskforce, was brought to order by Dr. Cristina Brito at 10:16 a.m. All members were welcomed, and introductions were made.	
Approval of Minutes	<p>There was a motion to approve the Children Issues Committee October 2025 meeting minutes by Isabel Afanador, and the motion was seconded by Jeffrey Hurst.</p> <p>There was a motion to approve the Healthy Baby Taskforce October 2025 meeting minutes by Zadymon Moore with a recommended edit to correct Dr. Brito's name in Partner Updates, and the motion was seconded by Candice Schottenloher with the recommendation</p>	
Executive Board Update	<p>The Executive Board update was provided by Dr. Cristina Brito. Recently, the Board met on Monday, November 3, 2025. Dr. Brito shared the Food and Nutrition for All Collaborative (FNFA) recently hosted a press conference with a call to action related to food insecurity issues Miami-Dade County is facing and could be dealing with related to the federal government shutdown and the loss of SNAP benefits and sharing local resources that are available.</p> <p>Dr. Brito shared a calendar-based Food and Nutrition For All Community Food Finder resource for families to search available free food resources and distribution events near them. It was also shared the FNFA has launched a Community Food Resource Partner Impact Survey to understand what food partners may be in need since there has been federal cuts impacting some of major partners that provide food to our community. Two surveys (the Resources and Tech surveys) were done in this regard to really understand how they were being impacted by the government shutdown. Follow-up surveys were conducted as well, to get the specific means. Based off the survey responses received, they needed the following food items: shelf stable, produce, hygiene products, toiletries, and baby products.</p> <p>The FNFA hosted Beyond the Table: Experience-Data-Policy Action Meeting on Friday, October 3, 2025. It was a session that integrated the connection between lived experience, data, policy, and action, and how you can make for change. The Quest Foundation awarded the Food and Nutrition For All Collaborative to be one of their grantees. The grant will be utilized to address food insecurity in Miami-Dade, and as part of it, will be looking at a mini grant process. The grant is expected to begin in January 2026. More details will be shared with committee members. Ongoing currently, there is a letter writing campaign led by United Way Worldwide on The Emergency Food and Shelter Program, including updates on the frozen Fiscal Year 24 funding situation. Additionally, the Board also finalized the 22nd Annual Consortium Event & Worksite Wellness Awards SWOT Activity and gathered feedback from the Event Planning Taskforce. This feedback will help us to better plan for the upcoming 2026 event.</p> <p>Lastly, the Executive Board reviewed their current work plan (2019-2025) and its accomplishments. The Board is reviewing their progress to see what still needs to continue to be addressed in the new 2025-2030 Consortium Strategic Plan and Executive Board work plan.</p>	
Healthy Baby Taskforce Update	<p>The Healthy Baby Taskforce is a sub-committee of the Children Issues Committee. The Taskforce last met virtually on October 17, 2025, and Esther provided an update and led a conversation on the current funding landscape with the partners. Tenesha announced during this update collaboration was welcomed to any organizations with related initiatives to reach out to the Taskforce liaison to help support the work of their partners as well as plan for the 2026 year. A brief update was shared on the Alliance for Infant and Maternal Health (AIM) Initiative led by The Women's Fund Miami-Dade. During this update, a call to action was proposed by Rocio Velazquez on the importance of collaborative efforts from Chairs and Co-Chairs from the Florida Association for Infant Mental Health (FAIMH), Miami Chapter, Healthy Baby Taskforce, AIM, Mayor's Blue Ribbon Commission, Breastfeed MIAMI, and the Children's Issues Committee to be part of a collaborative meeting to identify common ground for all of the different groups to plan strategically for the FY 25-26. It was recommended the Consortium welcomes a meeting as well as during the committee meetings to have representatives from the respective organizations and/or have a standing agenda item updated from a committee member who participates in these meetings. The Taskforce has also been reviewing the new Florida Healthy Baby FY 25-26 priority areas which include Well Woman Care, Maternal Mortality and Morbidity, Infant Mortality, Dental or Oral Care, and Children's Medical Homes. The Taskforce will focus on Infant Mortality and Children's Medical Homes.</p>	
<p>Previous Action Items</p> <p>2025-2030 Children Issues Work Plan Development</p>	<p>A high-level recap of the Community Health Improvement Plan (CHIP) priority areas was shared with the Children Issues Committee and Healthy Baby Taskforce members. The 2025-2030 CHIP Priority Areas include Access to Care, Chronic Disease Prevention, Behavioral & Mental Health, Maternal Child Health, and Healthy Weight/Physical Activity/Nutrition.
